### INTRO

*In 1997 a mobile communication tower was built next to a farm in Öttingen, Bavaria. By 1998 the swallows and the migratory birds were staying well away. ### ADHD and digital wireless transmissions are developing side by side

*uw.* News about the increase of ADHD among children and teenagers continues to come out. According to a 2013 report issued by the German health insurance company Barmer GEK, cases of ADHD increased by 42% from 2006 to 2011 among persons under 19 years of age. By 2011, around 620,000 teenagers and children had been diagnosed with Attention Deficit Hyperactivity Disorder with 472,000 of those being boys. The general use of digital wireless transmission

technology has increased rapidly at the same time. Most children today can be described as passive users of mobile phones or wireless internet as these devices are used in most homes in the form of mobile/wireless phones and WiFi routers. Exposure to radio waves coming from outside the house is increasing as well. Cellular networks are being expanded, four new LTE networks and one TETRA network are being constructed as well as the transfer to digital radio

(DAB) and digital television (DVB-T). Multiple studies have confirmed this correlation. It is also distressing that electromagnetic radiation has a negative impact on unborn children in their mothers' womb.

### Rehabilitation of the Iranian Mellat-Bank

The managing director of the Iranian Mellat-Bank reported that the European Court of Justice judged the sanctioning of the Mellat-Bank as illegal. Ali Diwandari said: "After a lawsuit of two and half years, the European Court of Justice in Luxembourg judged the claim of the EU as unrealistic and called the sanctioning of the Mellat-Bank un-

lawful for formal reasons and in regard to the content. The EU was ordered to refund the losses that originated from the sanctions. The managing director told our reporter: "In July 2010, the EU accused the Mellat-Bank of supporting terrorism and of sponsoring the production of weapons of mass destruction. The EU then sanctioned the Mellat-Bank.

Now in the European Court of Justice, the responsible persons of the bank have refuted all these accusations with documents during the court case. Diwandari added: "Because of the EU-sanctions, some of the international securities of the Mellat-Bank were sanctioned and therefore the bank could no longer do business with many companies. This

example supports the suspicion that the accusation of Iran producing a nuclear bomb is as untenable as the accusation of the Mellat-Bank supporting terrorism.

What is demonstrated above as a fictitious example is part of a test project: "An intelligent information system to support the surveillance, search and registration of suspicious people for the security of citizens in urban environments." This system will be able to observe all citizens in each public place and to check them immediately if their behaviour is "suspicious".

What's going on here? What behaviour will be considered normal?


